NARRATIVE

ARRIVED ON SCENE WITH LACOFD E82/S11 TO SUMMERKIDS CAMP ON FAIR OAKS AVE. ARRIVED ON SCENE TO FIND A 6 Y/O F PT IN CARDIAC ARREST, LIFEGUARDS ON SCENE WERE PERFORMING CPR PRIOR TO EMS ARRIVAL. PT FOUND LAYING ON SIDE OF POOL WITH CAMP LIFEGUARDS PERFORMING CPR. UPON EMS ARRIVAL, EMS TOOK OVER CPR. PER LIFEGUARDS AND STAFF ON SCENE PT WAS FOUND IN POOL UNRESPONSIVE, LIFEGUARDS ARE ESTIMATING APPROXIMATELY 30 SECOND DOWN TIME IN POOL BEFORE PATIENT WAS TAKEN OUT OF POOL AND CPR WAS INITIATED BY LIFEGUARDS. PER STAFF ON SCENE THEY WERE PERFORMING CPR FOR APPROXIMATELY 5 MINUTES PRIOR TO EMS ARRIVAL WITH NO CHANGES NOTED IN PATIENT CONDITION, UNKNOWN MEDICAL HX. ONLY INFORMATION PROVIDED BY STAFF WAS PATIENT NAME AND DOB CARD. CPR PERFORMED ON SCENE BY EMS FOR APPROXIMATELY 5 MINUTES BEFORE LOADING PATIENT ONTO GURNEY AND INTO AMBULANCE.

PT TRANSPORTED ALS TO HUNTINGTON HOSPITAL FOR FURTHER MEDICAL EVALUATION AND TREATMENT. IN BACK OF AMBULANCE LACOFD PARAMEDICS ESTABLISHED PINK IO IN LEFT PROXIMAL TIBIA SITE. PT WAS GIVEN EPINEPHRINE BY LACOFD PARAMEDICS EN ROUTE TO HOSPITAL, NO CHANGE IN PATIENT CONDITION. OPA PLACED IN PATIENT TO OPEN AND MAINTAIN A PATENT AIRWAY, OXYGEN PROVIDED VIA CHILD BVM WITH 15 LPM OXYGEN ATTACHED TO IT. GOOD COMPLIANCE ON BVM, NO RESISTANCE NOTED, GOOD CHEST RISE AND FALL. SPO2 PLACED ON PATIENT. PT ON PEDIATRIC AED PADS FROM LACOFD CARDIAC MONITOR. CPR WAS CONTINUED THROUGHOUT ENTIRE TRANSPORT WITH NO IMPROVEMENT IN PATIENT CONDITION.

AT DESTINATION PT PLACED IN ED BED 35, CPR WAS CONTINUED BY HUNTINGTON HOSPITAL PERSONNEL. NO IMPROVEMENT IN PATIENT CONDITION, FACILITY SIGNATURE OBTAINED, NO GUARDIAN/PARENT AVAILABLE FOR SIGNATURE, ALL TIMES APPROXIMATE.

UNRESPONSIVE IN POOL, APPROXIMATE DOWNTIME PER STAFF ON SCENE WAS 30 SECONDS. LIFEGUARDS PERFORMED CPR FOR 5 MINUTES
PRIOR TO EMS ARRIVAL. PT IN CARDIAC ARREST.

O: PT FOUND LAYING ON FLOOR BY POOL IN CARDIAC ARREST CPR BEING PERFORMED BY LIFEGUARDS ON SCENE. PT A&Ox0 GCS 3.

A: PT TRANSPORTED ALS TO HUNTINGTON HOSPITAL FOR FURTHER MEDICAL TREATMENT, CPR PERFORMED THROUGHOUT TRANSPORT WITH NO IMPROVEMENTS.

PT CARRIED TO GURNEY, PT PLACED ON GURNEY IN SUPINE POSITION ON BACKBOARD.

CPR PERFORMED BY EMS AND LACOFD, PINK IO ESTABLISHED BY LACOFD PARAMEDICS, OPA ESTABLISHED BY CARE EMT, CHILD BVM USED FOR VENTILATION GOOD COMPLIANCE, GOOD CHEST RISE AND FALL. EPINEPHRINE GIVEN BY LACOFD PARAMEDICS.
PT CONDITION REMAINED UNCHANGED. PT WAS TAKEN TO HUNTINGTON HOSPITAL ED. PT PLACED IN ED BED 35. PT CARE TRANSFERRED TO STAFF.
